The Market Manager reviews vendor applications and product(s) for acceptance to the Holiday Markets. Priority is given to vendors who: operate in Wilkes County, have seniority, offer a high percentage of locally produced food products, and add diversity to the overall product mix at the Market. The Market Manager reserves the right to limit the number of vendors for each product area to ensure a diverse and sustainable product mix for the Market based on space availability and the Market's priorities.

State Law (N. C. Gen. Stat. § 66-255) requires every vendor, defined as "a person engaged in business in this State and selling tangible personal property, and certain digital property at retail, or rendering a taxable service at specialty markets, flea markets, fairs, festivals, sporting events, entertainment events, and other events and functions", to "register with the North Carolina Department of Revenue" and "collect and remit sales and use tax unless a specific exemption applies to the product sold." Therefore, every vendor must provide one of the following at the time of application and display a copy at their booths Certificate of Registration Number, Qualifying or Conditional Farmer Exemption Number.
