If you sell produce, meat, and/or eggs, you are eligible to participate in the Market Bucks Program. The Market Bucks Program provides vouchers, or "bucks," to select households to use at local markets like ours to purchase fresh fruit, veggies, meat, and eggs. Eligible vendors can accept "bucks" as payment and request reimbursement by turning their bucks in to the Market Manager. Reimbursement will operate on a bi-monthly basis. Please indicate below if you are an eligible vendor and would like to participate in the Market Bucks program.

Vendor applications and product(s) are reviewed by the Market Manager for acceptance to the Market. Priority is given to vendors who: operate in Wilkes County, have seniority, offer a high percentage of locally produced food products, and add diversity to the Market's overall product mix. The Market Manager reserves the right to limit the number of vendors in each product area to ensure a diverse and sustainable product mix for the Market, based on

space availability and the Market's priorities.

State Law (N. C. Gen. Stat. § 66-255) requires every vendor, defined as "a person engaged in business in this State and selling tangible personal property, and certain digital property at retail, or rendering a taxable service at specialty markets, flea markets, fairs, festivals, sporting events, entertainment events, and other events and functions", to "register with the North Carolina Department of Revenue" and "collect and remit sales and use tax unless a specific exemption applies to the product sold." Therefore, every vendor must provide one of the following at the time of application and display a copy at their booth: Certificate of Registration Number, Qualifying or Conditional Farmer Exemption Number.

Vendors may choose to become a Market Sponsor for a fee of \$20, which includes logo recognition on a premium-location market sponsorship banner displayed throughout the market season, as well as one "thank you" post on the market's social media platforms during the 2026 season, acknowledging the vendor's support. This sponsorship helps support market operations and promotional efforts while providing added visibility within the community. Returning vendors may include the \$20 sponsorship fee with their vendor fees at the time of application or renewal.
